The Medical School

The Gozo Tourism Association welcomes the signing of the Memorandum of understanding signed earlier this year, between the Government of Malta, the Barts and the London School of Medicine and Dentistry of Queen Mary University for the setting up of a campus hosting a medical and dental school on the site of the Gozo General Hospital.

The set up of such a medical training teaching institution is considered by the Gozo Tourism Association, as an encouraging step forward to stimulate the socio and economic development on the island of Gozo.


Collective Accommodation Performance January to June 2016

Following the release of the collective accommodation statistics compiled by the National Office of Statistics for the month of June 2016, the GTA notes the decrease in tourist arrivals and bednights during June. The decreases of 4.5% in arrivals and 10.5% in bednights have to be analysed objectively in order to have a more comprehensible picture of the tourism scenario on Gozo. However these decreases should be looked into and taken seriously, since this is the second consecutive month that the Gozitan hotels registered a decrease, after double digit growths in the preceding winter 2016 months.



It is of utmost importance to state that the aforementioned statistics relate to the collective accommodation in Gozo, which includes the 9 hotels, guesthouses and tourist villages representing just over 2000 beds or 28% of the licensed beds in Gozo. These same statistics do not cover the non-collective accommodation that includes mostly, the farmhouses and the apartments. This accommodation segment group approximately 5000 licensed beds in Gozo or 72% of the island's total bedstock.

There are several reasons which need to be taken into consideration when faced with these statistics. On analysing further the tourist bednights, there are indications of changes in the tourism accommodation sector. It is evident that lately there has been a shift from the collective accommodation to the non-collective accommodation. This was corroborated by various indicators. The main accommodation providers in the self catering sector confirmed that they registered better occupancies both in May and in June when compared to same period of last year.



The decreases in the collective accommodation were higher in lower categories i.e. the three star hotels, guesthouses and tourist villages. In fact these two categories registered a decrease of 17% and 15% respectively. Here it is worth pointing out that presently one can find 60 accommodation units in Gozo operating under the Bed & Breakfast trade name. Since this type of accommodation property falls under the noncollective accommodation, these units are not obliged to furnish NSO with their occupancies. A rough calculation of these units will add up to approximately 360 more beds in direct competition with the hotels sector. Furthermore one cannot exclude to mention those properties that are not licensed, yet are featured and bookable on several online booking engines. These are also increasing the bed supply on Gozo, while offering unfair competition to the licensed accommodation units.

In the circumstances the GTA calls for a concentrated effort to tackle the issues mentioned above. In this respect in its Budget 2017 proposals the GTA will be suggesting measures to strengthen the Gozitan Hotels sector, and if taken on board these measures will entice the Hotel owners to invest in the upgrading and refurbishment of their accommodation offer. The Gozo Tourism Association recommends that the time has come to have a more comprehensive Gozitan accommodation data that covers and includes all type of units. Only through these statistics one can really measure the Gozitan tourism achievements or otherwise.

Finally the GTA augurs that all those involved in the tourist industry persist in doing their utmost to continue enhancing better prospects in the Gozitan Tourism industry. The GTA, believes that more has to be done by all stakeholders involved in order to maintain the numbers registered during these last years.

Budget 2017 Proposals by GTA

As is now customary around end September the Gozo Tourism Association prepares a set of proposed measurers aimed to enhance the tourism sector in Gozo. These proposals are then presented to the Minister for Finance, the Minister for Gozo, the Minister for Tourism and the Opposition Shadow Minister for Gozo. For the benefit of our members we are listing hereunder the salient measures listed in the aforementioned proposals.

CONNECTIVITY

- That funds are allocated for another study to identify an alternative site for the construction of the airstrip other then the earmarked one at Ta' Lambert
- The GTA is proposing a change in the ferry fare structure, with the introduction of a seasonal ticketing systems by Gozo Channel as details below:

Low Season Fare
January, February, November and December

Mid Season Fare March, April and May

High Season Fare
June, July, August, September and October

• The GTA is once again proposing that during the low and mid seasons all passenger and vehicle crossings during the weekends are to be changed at rates relative to the Gozitan residents fare. GTA is therefore proposing an increase on the current estimates of €200,000 allocated for such a scheme to the Gozo Ministy, since this sum covers only four weekends.



- GTA is proposing once again the introduction of a Ferry Guaranteed boarding, a scheme intended
 to facilitate tourists connecting with incoming and outgoing flights, thus saving on lost overnights
 in the Gozitan accommodation.
- In order to make up for the termination of the Sa Maison Cargo Service the GTA is proposing that heavy transport vehicles who crosses over to Malta with the night ferries will do so Free of Charge
- Provide redundancy in addition to three existing ferries, as a contingency for any breakdown to the present ferries, as well as to meet heavy demands during peak periods.
- Fast track the study and the PSO issue to introduce a fast ferry service to Valletta
- The setting up of a Shuttle service between MIA and Cirkewwa with the prime objective to minimize the transfer costs of the MIA—Cirkewwa Sector.
- The GTA is proposing the necessary infractructural investment in a cruise berthing buoy off Xlendi Bay, a new buoy off Mgarr Terminal and Marsalforn in order to offer alternative berthing facilities around the West, North West and South coast of Gozo.

THE PRODUCT

 GTA urges Government to fast forward the amendments to the Tourist Act as soon as possible preferably by the end of this summer season 2016

Amend the present accommodation VAT rate on Gozo as follows:

November to March 3%
April to October 7%

 An accelerated depreciation on tourism accommodation upgrading and refurbishment including product development and operational infrastructure as well as energy generation/efficiency to cater for replacement every 5-7 years

- All types of accommodation having a swimming pool and which are covered by an operating license issued by the Malta Tourism Authority will be exempted from this 15% increase on the swimming pool license.
- A tailor-made Tourism Investment Support Scheme (TISS) to entice local entrepreneurs to upgrade their Gozitan Tourist Establishments. Such scheme can be financed and piloted by the Ministry for Gozo and in collaboration with the Ministry for Tourism together with the active participation of the GTA
- The upkeep on regular basis of the rural roads leading to self catering accommodation for easier access, especially during winter time.
- The setting up of a Tourist Upkeep Unit which will own, maintain and manage several tourist spots like: Qbajjar Promenade, Three Hills Garden in Marsalforn, The Villa Rundle Gardens, Zewwieqa Waterfront, country walk paths, dive sites etc.
- The development of sports facilities including an athletics track and training camp facilities that can be incorporated in the Ta' Xhajma Race Track
- A Subvention is allocated to the Cittadella Management Committee to continue with the ongoing maintenance and upkeep of the newly restored Cittadella until such time this same Management Committee finds alternative funds to sustain its remits.

NICHE MARKETS

- A financial subvention is to be made available for the implementation of several actions advised in a three year marketing plan commissioned by GTA in 2016
- The small conferences sponsored and/or organised by Government are to be held in Gozo
- A Public Private Partnership (PPP) project should be piloted and taken in hand by Governnment for the development of a centralized, well equipped Conference Centre on Gozo.
- The GTA urges all parties involved to reach an agreement between Government, the two Gozitan Opera Theatres and other stakeholders to establish an official opera season

NICHE MARKETS

- The GTA is proposing the setting up of a fund to enforce and manage the established Marine Protected Areas in and around Gozo in order to increase marine life. This fund can be managed by the already established Management Committee of specific touristic resorts.
- The drafting of Rural Tourism Policy and including Agri-Tourism
- The implementation of the Diving Master Plan by the Ministry for Gozo which was carried out through EU co-financing way back in 2006 and up date the actions proposed in this plan which plans were never activated due to lack of funds.

HUMAN RESOURCES

- Training schemes (practical and Theoretical) during the winter months aimed at improving knowledge and skills in the
 tourism industry, including training in soft skills and languages while encouraging retention of employees during off-peak
 months, sustained through grants coupled with employer and employee full NI credit.
- Scheme targeted toward new employees with MQF Level 5 and upwards residing in Gozo in micro touristic units, subject to credits on employers and employee NI for a period of three years.
- More synergy between the ITS Gozo and the Gozo Tourism Association.
- The NSO office in Gozo should have an allocation of funds for the Gozo Specific Statistics including tourism and commuting
 patterns. This data should include tourism related figures together with other relevant data that constitutes the whole
 Gozitan tourism product.

Budget proposals discussed at MCESD

Since the Gozo Tourism Association is founder member of the Gozo Regional Committee a representative of which sits on the MCESD, some of the above proposals were included in the Budget Proposals put forward by the Gozo Regional Committee. During a full day meeting between the MCESD members and the Minister for Finance held on 12th September 2016 the aforementioned proposals were brought for the attention of the Minister concerned and discussed at length.

We are positive that in the long run some of these proposals will by time gain the necessary support and will be implemented for both the benefit of the Gozitan Tourism Industry, in particular and for the Gozitan economy.
